INTRODUCTION

British Association of Chartered Physiotherapists in Amputee Rehabilitation

The British Association of Chartered Physiotherapists in Amputee Rehabilitation (BACPAR) is a professional network affiliated to the Chartered Society of Physiotherapy (CSP). BACPAR aims to promote best practice in the field of amputee and prosthetic rehabilitation for the benefit of patients, users and the profession. It is committed to research and education, providing a network for the dissemination of best practice in pursuit of excellence and equity, whilst maintaining cost effectiveness.

This guide to the resources available for research and audit was first published in 2008 and has now been updated and new information has been added. It provides a comprehensive list of databases to enable the researcher to find articles relating to the specialised area of amputation rehabilitation as well as broader areas of healthcare.

Searching the Literature

Learning Resource Centres and Libraries within Hospital Trusts and Universities will provide guidance and advice and have the resources to help with literature searching. Training sessions on literature searching are often available and some guidance documents may be available on Trust or University intranet sites.

A useful explanation is given on the British Nursing Index home page on the Glasgow Caledonian University library website.

Before beginning a literature search it is useful to formulate the research question and consider the terms which may be most appropriate. Consider using the PICO model:

Patient – what are the characteristics of the patient? Intervention – What are you going to do? Comparison – What is the alternative? Outcome – What is your intended outcome?



DATABASES and EVIDENCE BASED WEBSITES

Search alerts can be setup for most databases to notify of new articles of interest.

National Electronic Library for Health

AMED – Allied & Complementary Medicine

AMED provides an alternative medicine database for physicians, therapists, medical researchers and clinicians looking to learn more about alternative treatments - including complementary medicine, physiotherapy, occupational therapy, rehabilitation, podiatry, palliative care, and more. AMED contains basic bibliographic records (abstracts are also included for many records dated 1995 onward) for relevant articles from over 500 journals, with the scope of coverage being mainly European.

Many of the journals included in *AMED* are not indexed by other biomedical sources. *AMED* is produced by the Health Care Information Service of the British Library.

The British Nursing Index (BNI) is a bibliographic database that indexes articles from the most popular English language nursing journals published primarily in the UK. BNI is a comprehensive index covering all aspects of nursing, midwifery and community healthcare from 1985 to the present, and is updated monthly. This database is supplied by ProQuest.

CasesDatabase

Launched in 2013, the Cases database is a continuously-updated free-to-access database of thousands of case reports from multiple publishers and PubMed Central. By aggregating case reports and facilitating comparison this database allow clinicians and researchers to identify emerging trends, new associations, new side effects, new thoughts about disease processes and new understanding about the impact of disease on patients lives.



CINAHL- Cumulative Index to Nursing and Allied Health Literature http://www.cinahl.com/

Encompasses authoritative coverage of nursing and allied health. Provides access to a large proportion of English-language nursing journals and includes selected articles from approx. 3200 biomedical journals indexed by Index Medicus.

CINAHL Plus with Full Text provides full text for hundreds of journals indexed in the CINAHL database, and includes a higher number of records, additional journals, records dating back to 1937 and expanded content. Additional material includes Evidence-Based Care Sheets and Quick Lessons which provide concise overviews of diseases and conditions and outline the most effective treatment options.

The Cochrane Library http://www.thecochranelibrary.com/view/0/index.html consists of a regularly updated collection of evidence-based medicine databases, including The Cochrane Database of Systematic Reviews. This database includes systematic reviews of healthcare interventions that are produced and disseminated by The Cochrane Collaboration.

Cochrane Reviews are <u>systematic reviews</u> of primary research in human health care and health policy, and are internationally recognised as the highest standard in <u>evidence-based health care</u>. They investigate the effects of interventions for prevention, treatment and rehabilitation. They also assess the accuracy of a diagnostic test for a given condition in a specific patient group and setting.

With over 24 million indexed records and more than 7,600 currently indexed peer-reviewed journals, Embase is a highly versatile, multipurpose and up-to-date database covering the most important international biomedical literature from 1947 to the present day. All MEDLINE records produced by the National Library of Medicine (NLM) are included, as well over 5 million records not covered on MEDLINE.

This evidence based database has been developed to give rapid access to bibliographic details and abstracts of randomised controlled trials and systemic reviews in physiotherapy. Most trials have been rated for quality to help identify trials that are valid and interpretable. All randomised controlled trials are rated for methodological quality using a specially-designed scale (the PEDro scale). Physiotherapists can visit the PEDro web-site and use powerful, user-friendly search strategies to obtain bibliographic details and author abstracts of all relevant systematic reviews and randomised controlled trials, ranked according to methodological quality.
